

### **International Empanelment of ECI Coordinators**

### A. Eligibility conditions

- Candidate should have a minimum professional experience of 10 years, postacquisition of engineering qualification from a recognized Engineering Institution/ University from India/ Professional Guild recognized by Government of India to issue equivalent certificates.
- 2. Should have attained a minimum age of 35 years.
- 3. Should be working/ has worked, with an organization involved with Engineering activities. Those in the field of academics are also eligible.
- 4. Should be willing to adhere to the ethics policy of ECI.
- 5. All applicants should either hold a valid Registration certificate of Professional Engineer (PE) or above (as SrPEs), issued by ECI or be willing to register as one. In this case they may submit their application along with the prescribed fee to ECI secretariat & make a mention of this in their application.

- 4. Conduct Research/ Studies on emerging topics.
- 5. Participate in ECI conferences/ Award functions.
- 6. Support in establishing local chapters in their region & steer the same.
- 7. Provide regular reports to ECI headquarters & join international review meetings. AND
- 8. Implement new initiatives as launched by ECI from time to time

#### D. Benefits / Incentives for ECI Coordinators.



- 1. Revenue sharing as per ECI norms for all accruals, arising from the work done by them.
- 2. No delegate fee/ Participation fee in ECI events.
- 3. Earning recognitions/ Awards for good performance.

# E. Fees/ Screening Charges.

- 1. Those, who hold valid registration Certificate of PE or above (as SrPE) by ECI
  - Only Screening Charges of Rs.3,000/- + GST(Validity 2 years)
- 2. Those, who don't hold valid registration Certificate of PE or above (as SPE) by ECI
  - Registration charges as prescribed
  - Screening charges as defined above.
