Objective

In view of the high number of dilapidated buildings and recent collapses, safety of people and fitness of buildings for human habitation have emerged as prime concerns. As a result, the need for regular structural assessment is being felt more strongly than ever before. Maharashtra Act No. VI, through its amendments to various municipal corporation acts has made 'Structural Audit' mandatory for all buildings, which are older than 30 years. Municipal corporations have also brought out their guidelines and framed their requirements for Structural Audit.

It is the need of the hour to take a closer look at various aspects of structural assessment with particular reference to the scope, methodology and limitations of Structural Audit. It is also necessary to understand various provisions under the recent amendments and to deliberate on different issues and impediments concerning implementation thereof.

This Program is designed to guide the participants to carry out Structural Audit, interpret their findings and NDT results and prepare an Audit Report. It will also offer practical insight into the subject through case studies and active interaction with the participants.
